



**Mind Control Pre-Revolution**  
**(MC Pre-Rev)**

## What is the Mind Control Pre-Revolution?

The MC Pre-Rev is NOT a militia group. The MC Pre-Rev is a science fiction fantasy club which spends idle time discussing risks associated with technologies which may decode brain activities; risks include use of this information for the purpose of the mental enslavement of humanity. Since such technology is patently impossible, we strongly encourage those who truly believe this is possible to report to wellness authorities.

On the outside chance, however, that at some future date an alien species manages to teach humans how to mentally enslave each other (or any analogue thereof), and some rogue elements in the dark state or elsewhere manage to get away with setting up a network that could accomplish the feat of decoding human brain activities by use of some means of remote monitoring and also influencing human neural processes from a distance, this science fiction fantasy club is dedicated to widespread societal organization to root out those in and out of government who perform **involuntary experimentation** upon persons specifically inclusive of doing so with a view towards psychological dominance or even mental enslavement of some or many persons. Steps with unmitigated risk factors, towards mental enslavement of some or many persons, would likely be of particular interest; banning sentences in excess of 100 words or 200 characters will also be considered.

In the meantime, of course, this pro-government pro-peace pro-security anti-terrorist science fiction fantasy club should not be of any concern whatsoever to any arms of the state for the simple fact that discussions concern technologies which patently do not exist and which are probably impossible anyways. In the interest of avoiding monitoring and/or surveillance, this pro-government pro-peace pro-security anti-terrorist group suggests that any concerns whatsoever on the part of any intelligence, military and/or law enforcement organizations (or any organizations with similar areas of activity) should be brought directly to the attention of the MC Pre-Rev so that the MC Pre-Rev will have the opportunity to prove through action, more so than word, that the group is entirely benign, in particular considering that this anti-brainwashing anti-mind control science fiction fantasy club is generally preoccupied with discussing categorically impossible concerns.

Why join? Because for some ... strange ... reason ... a lot of people just seem to have a lot of time on their hands. Also, the mental enslavement of humanity would suck, so we should talk about such risks.

## Who we are looking for

Anyone who is a fan of science fiction fantasy and who thinks the potential for mental enslavement of humanity is something that should be spoken about openly is welcome. In particular, the following are sought for their interdisciplinary and creative skills:

- Musicians
- Artists
- Bloggers
- Social media activists
- Budding journalists
- Film students, directors, etc.

- Office volunteers for administrative management, etc.
- Volunteer coordinators
- Holders of an MA and above in physics, psychology, materials sciences, religious studies, linguistics, literature, history, archaeology and other related fields. Such individuals are well-poised to present critiques of a) theories relating to the risks that this science fiction fantasy club is concerned about and b) critiques of defensive civilian strategies if the mental enslavement of humanity ever enters onto the radar of being within technological plausibility.
- People with zero, one or two legs who are interested in and/or concerned about this area of intellectual exploration. Those who required three- and/or four-legged assistants are also welcome.

## **The Mind Control Pre-Revolution and the establishment**

Formal officials are invited to self-identify and are welcome at all events. Covert entities are not welcome, and may be peacefully ejected if psy ops or "agent provocateur" operations persist.

Authorities are asked to immediately inform the MC Pre-Rev if any activities, information or promotional materials may be suggestive of concern with regard to any law, or suspicion with regard to any law. Organizational principles, information diffused and activities will be adjusted accordingly. Or better yet, encourage people to join the Pre-Rev.

In terms of time and resource allocations for ensuring transparent and trusting linkages with the establishment, the following are presently proposed:

- Transparent liaisons should be established with all political parties with elected representatives – attend free events for the purpose of soliciting representatives' comments on specific questions.
- Periodically survey various elected and appointed public servants, in addition to some diversity of civil society leaders, to assess knowledge relating to key issues on the question of mind influencing technologies and/or potential programs relating to them, and in particular whether it may be time to eliminate the "science fiction fantasy club" denotation of the MC Pre-Rev.

## **Free speech and the Mind Control Pre-Revolution**

Friendly debate, designed to ask good questions and not to silence people or make anyone feel dumb, is at all times welcome. Newbie questions will generally be directed to the relevant documents, in order to prevent wastage of time and cognitive resources. Specific critiques of any such resources and proposals towards additional informational resources are strongly encouraged.

Debate and discussion should generally strive to stay on the main topics of interest to the science fiction fantasy club, and any appearance of efforts to intentionally waste time by changing the subject to unpromising areas of discussion or to intentionally stir up bad blood in the process of discussion and debate will not be tolerated. However, it should be anticipated that discussion may be lively, even heated, at times.

Free speech should at all times be upheld, so long as it does not cross the line into slander, hate speech or other illegal activities. Of course, unpopular ideas will always be tolerated, encouraged even, so long as the links to the objectives and interests of the MC Pre-Rev can be made at least peripherally clear.

## **Where will the non-human resources come from?**

- Not-for-profit commercial activity (various merchandise, goods and services, etc.);
- An open source publishing house for independent print media aligned with the interests and concerns of the Mind Control Pre-Revolution science fiction fantasy club;
- Monetary donations will not be prioritized.

## **Objectives of the Mind Control Pre-Revolution**

GOAL 1: Mind influencing technologies clarified widely.

GOAL 2: Amass historical documentation on individual experiences related to these technologies and strategies, in particular in the Canadian context.

GOAL 3: Incorporate anti-brainwashing curriculum into educational programs in Canadian provinces, via appropriate materials significantly integrated into the content of 2-10 class periods at the high school level. In addition to basic awareness of technological capacities in the event of such risks, this should also cover some scope of non-technological aspects of the risks, how to identify them, and psychological preparedness.

GOAL 4: Assert full social, legislative and judicial control and oversight over all aspects of the security state which deal with any source of information or treatment of domestic citizens. This does not suggest that no state authority is required to uphold peace, good governance, etc. – what it suggests is that those who enforce and/or investigate laws should be held accountable to those laws established by voters/taxpayers who pay their salaries.

GOAL 5: Failing the above (with the possible exception of goal 3), refer to the "right to resist tyranny".

The Mind Control Pre-Revolution is 100% dedicated to peaceful and legal means of Mind Control Pre-Revolution until a sufficient body of evidence from official sources, including statements from elected representatives, civil servants, military and intelligence officers, etc., in addition to peer-review scientific evidence, can testify to science fiction having transformed into science real. At that time, a legitimate right to revolution may become established, but it is assumed that any such additionally enhanced explicit technological awareness that leads to sufficient and broad public disclosure of these patently impossible technologies, would trigger normal democratic processes to assert social and democratic oversight over any and all relevant actors within the state, or other hypothetical terrorist actors, which may pose a threat to public safety – at which point in time the Mind Control Pre-Revolution would fully disassemble and members be encouraged to revert to lobbying for open source Anti-Brainwashing League materials to be included in educational curriculum.

## **What do we do to those who do not “GET IN”?**

Mind Control Pre-Revolutionaries may wish to seek means to effectively embargo against pro-mind control businesses by encouraging businesses to publicly display their support for the Mind Control Pre-Revolution, for example by attaching the logo, which is open source, to their advertising campaigns. The authenticity of such indications should not be questioned.

## **Protecting against hostile infiltration and inducements to perform acts which may serve as blackmail at a later date**

The MC Pre-Rev has a horizontal and transparent offline communications and planning structure; if you want to participate and communicate, just bring yourself. This implies a necessity for adequate protections against potential ‘agent saboteurs’ to prevent being ‘taken over’ or blackmailed by those who may wish to silence the Mind Control Pre-Revolution science fiction fantasy club.

Membership in the Mind Control Pre-Revolution science fiction fantasy club is conditional on a commitment to immediately report to appropriate authorities any instance where any member tries to induce a member of the Mind Control Pre-Revolution to engage in any illegal act related to any form of mental, physical or sexual violence or any form of financial crime relating to taxes, fraud, etc.

To uphold privacy principles, the ideal of always asking explicit permission to record any personally identifying sound or image should be upheld, and a negative response is to be respected. Open debate on the matter of upholding transparency and privacy simultaneously may be actively pursued in ‘unofficial’ venues until such a time as sufficiently concrete suggestions can be debated or even agreed upon in person.
